REQUEST TO REGISTER FOR AN OVERLOAD

This document lists guidelines pertaining to Overload Requests for the College of Criminal Justice. Please review the information below *before* completing the Request to Register for an Overload Form.

In order to be classified as a full-time student you need to be registered for at least 12 semester credit hours of course work for the Fall, Spring, and Summer semesters. The maximum loads are as follows:

Maximum load: Summer (this includes both Summer I and Summer II) 14 hours
Fall and Spring 19 hours

If you desire to take more than this you should be aware that the extra demands may harm your progress in some, and perhaps, all of the courses you take. You need to explain and justify why you need to take more than the maximum load hours and you need to outline your schedule (including any outside employment, commuting, etc.) All questions must be filled out in order for your Overload Request to be reviewed and processed.

Guidelines:

Requirements for Overload Approval

- Students must have an SHSU GPA in order to be reviewed for an Overload Request.
- Recent Grade history and academic performance must both indicate success.
- The nature of all courses the student wishes to register for are considered.
- External Factors and commitment to commuting time, work-related activities, and/or participation in campus activities will be considered.
