#### **Socrates in the Schools Project:**

In summer 2010 led the SHSU P4C Interest Group in securing a \$6,000 grant from the Powell Foundation in Houston for a replication at Mance Park Middle School in Huntsville of a Scottish study of the impact of one-hour per week Philosophy sessions on middle-school students' cognitive abilities as assessed by the Cognitive Abilities Test (CogAT). The Socrates in the Schools project started in August 2010 with a workshop for participating Language Arts teachers, and continued throughout the rest of the 2010-2011 school year. It was successfully concluded in Spring 2011, and led to two publications (1) "Socrates in the Schools from Scotland to Texas: Replicating a study on the Effects of a Philosophy for Children Program" by Frank Fair, Lory Haas, Carol Gardosik, Daphne Johnson, Debra Price, and Olena Leipnik in the Spring 2015 issue of *Journal of Philosophy in Schools*, 2(1), pp. 18-37, and (2) "Socrates in the Schools: Gains at Three-Year Follow-up" by Frank Fair, Lory Haas, Carol Gardosik, Daphne Johnson, Debra Price, and Olena Leipnik in the Fall 2015 issue of the *Journal of Philosophy in Schools* 2(2), pp. 5-16.

#### **Development of the Texas Assessment of Critical Thinking Skills (TACTS) Test**

In collaboration with two colleagues from the SHSU College of Business Administration, Dr. Valerie Muehsam and Dr. John Miller, and a Psychology graduate student, Wendy McCoy, I embarked on a project starting in Summer of 2004 and continuing to the present. The project, which was supported by the COBA dean, is to develop a test of reasoning abilities that can be used to assess progress made by students in SHSU's COBA in order to provide data for re-accreditation by the AACSB. In the Fall of 2006 the Texas Assessment of Critical Thinking Skills (TACTS™) was ready for use. As a result of this ongoing research and development program I have a co-authored presentation at the 2007 annual Decision Sciences Institute conference and a co-authored publication accepted: "TACTS™: Developing a New Critical Thinking Assessment Instrument" appearing in *Inquiry*, Vol. 25, No. 2 (Summer 2010), a journal dedicated to critical thinking instruction across the disciplines.

#### **Comparative Study of Argument Diagramming Software**

Along with a Psychology graduate student, Wendy McCoy, in 2003 I received funding from the SAM Center and the Office of Institutional research to determine if a computer assisted instruction package known as Reason!Able would enhance the critical thinking skills of students in our PHL 262: Critical Thinking classes as reported in the relevant

literature. We administered the California Critical Thinking Skills Test to our Fall 2003 classes to determine a baseline, and then used Reason!Able with our Spring 2004 classes to see if there was any discernable change. No significant difference was detectable.

### **Survey of Post Tenure Review in Texas Universities**

“Post Tenure review in Texas State-Supported Universities: A Broader View.” After completion of an initial two-year project studying post-tenure review in the Texas State University System, in the summer of 2000 I wrote an application for an AAHE funded follow-up grant. The application was successful, and so we were funded for an additional year to extend our research on post-tenure review to other state-supported universities in Texas during 2000-2001. TAMU, SFA, U of H, Texas Tech, UT Tyler, UT Arlington, and UT Pan American are all collaborated with the project.

### **Survey of Post Tenure Review at Lamar University, Sam Houston State University, Texas State University, Sul Ross State University, and Angelo State University**

“Post Tenure Review in the Texas State University System” was funded in 1998 as part of the New Pathways II project of the American Association of Higher Education. I was the principal investigator along with Dr. Debra Price. Other members of the SHSU PTR Research group are Dr. Laverne Warner, Dr. Jo Ann Duffy, Dr. Paul Reed, Dr. Bill Fleming, and Dr. Dennis Longmire. This was a two-year project during which I led the team members in a study the operation of the post tenure review process first on the SHSU campus and then on the other campuses of the Texas State University System. The study employed a combination of faculty surveys and structured interviews with key stakeholders, including legislators, administrators, and faculty.

### **A Comparative Study of the Impact of the ODYSSEY Thinking Skills Program**

“An Investigation of the Effects of a Thinking Skills Program on Reading and Writing Achievement.” The research was conducted during the 1986-87 school year with Dr. Sheila Cohen. We received a \$3,000 University research grant to study the impact of the ODYSSEY thinking skills program on students at two area junior high schools. The study involved nearly 180 students in the control and experimental groups and 5 teachers. After 5 months no significant differences on the Gates-McGinitie Reading Test and on the TEAMS test were observed.
