# **Approval of Minutes.**

Chairman Breazeale, discussed the University Diversity Committee document and the list of senate concerns were presented to the Provost. A senator recommended adding political diversity to the University's diversity plan.

The Chair clarified the Provost's position on Doctorate level faculty course releases.

Regarding academic dishonesty there was discussion about how multiple offenses would be accounted for? Several senators expressed concern about weak administrative support in academic dishonesty cases. Senators voiced interest in continuing to pursue ways to improve academic dishonesty reporting and action. In addition, are there limits to faculty's storage or keeping of student records?

Parking. The senate was asked to ideate a parking waiver process for on campus events. Assigned to the University Affairs Committee.

#### New Business.

Invitations to campus speakers. Recent events regarding invited campus speakers prompted senate discussion about the invitation process. Several Senators stated that hearing a wide range of ideas was an important aspect of the University experience.

Some conversation ensued about The Dean of Students and their role in any grievance or grade concern.

There was discussion about the role of the Faculty Senate. Should the Senate's decision making authority be expanded? This discussion was tabled.
