## Chair's Report.

Topics addressed included; Electronic Faculty Review Portfolio in Talent Management Hazelwood at UNT DO School Dishonesty Tracking

In regard to the Electronic Faculty Review Portfolios, some colleges are being required to submit portfolios in multiple formats.

Currently, we should expect that the Hazelwood exemption would apply to our planned D.O. program. In addition, COCA accreditation of the program and Coordinating Board approval are proving to be a challenge.

The Provost is agreeable to the senate proposing solutions to the university's tracking of Academic Dishonesty.

#### **Old Business.**

The following policies have been delivered to the senate for review and recommendations. The Chair asked for open discussion on the policies in effort to provide some initial guidance to the individual committees.

810213 (Academic Dishonesty) [Charged to Academic Affairs]

900417 (Reappointment, Tenure, Promotion) [Charged to Faculty Affairs] 900823 (Student Grievance) [Charged to Committee on Committees] 910312 (Academic Probation and Suspension) [Charged to University Affairs]

There was lengthy conversation on the topic of academic dishonesty and the wide range of its interpretation.

In regard to tenure and promotion policy, the timeline promotion and tenure is not satisfactory. The policy should specify that candidates be notified of upcoming deadlines and application expectations. In addition, there was significant discussion regarding the role of collegiality in the promotion process with many senators expressing a desire to remove the term from the process.
