#### **Guest Speaker – President James Gaertner**

President Gaertner compared his goals provided in his initial speech to faculty in September, 2001, to what has been accomplished thus far. He addressed:

- Capital campaign to be initiated.
- Personal visits to accomplish "friend raising before fund raising"
- Pride of students in SHSU
- Salary increases over three years
- Moving outside our comfort level to grow
- Academics First supported with less budget cuts for Academic Affairs

## President Gaertner's continued goals for SHSU include:

- Increased requirements for promotion and tenure
- Increased enrollment to fund the 9-hour teaching load
- Increased funding from outside the university including
  - o Special appropriations from the legislature
  - o Alumni contributions

#### Questions were posed regarding:

- Parking [He plans to study some of the suggestions made to ease the current situation.]
- Participation of faculty in tenure/promotion decisions [He is committed to including the faculty as part of the decision-making process.]
- Promotion & Tenure [Guidelines need to be determined collaboratively with the Provost distributing what has been finally determined.]
- Communication [He agreed that it needs improvement.]
- Mediation [He supports mediation in grievances and saw it work well at University of Texas San Antonio where there was an ombudsman.]
- Tribunal [The administration followed the guidelines of the Texas State University System.]

# Chair's Report No APC Meeting:

## Meeting with President Gaertner

- The Faculty Senate Survey results are, in fact, used to assist in making decisions and were instrumental in the recent restructuring of the university.
- Dean Brown will chair the Search Committee for the VP of Enrollment Management

## **Senate Input**

- A motion was made and passed to recommend that SHSU use hang-tags, one per person, rather than decals for parking registration.
- A motion was made and passed unanimously to recommend that all university vehicles currently parked in white-tag lots be housed in an area such as Sam South rather than using faculty parking space.
- There was some concern regarding where the new Information Center would be constructed and whether the green-lawn area near Estill would be compromised. There was also some discussion regarding the reforesting of areas in which trees had been felled for construction, such as the newly constructed base-ball field.

Next meeting will be Thursday, February 19. The guest speaker will be Provost David Payne.
