Called to Order

3:30 PM, by Outgoing Chair, Samuel Adu-Prah (COSET). Meeting turned over to current Chair of the Senate, Zachary Valdes.

Acknowledgement of Outgoing Senators

Dr. Adu-Prah presented certificates to outgoing senators. Provost Stephenson presented a plaque to Outgoing Chair Adu-Prah.

Discussion with Special Guests, Dr. Stephenson, Dr. Gaillard, and Dr. Hargrave

In response to a question about communication and merit raises, Dr. Stephenson shared that President White had hoped last year that enrollment would increase, and delayed her decision about merit raises accordingly; however, enrollment is down. The Provost does not expect a hiring freeze.

Dr. Stephenson and Dr. Gaillard addressed reasons why our enrollment may be down compared to other TSUS campuses. Some campuses benefitted from dual credit enrollment. Dr. Gaillard shared the hypothesis that raising the threshold for automatic admission caused some potential freshmen to apply elsewhere. This threshold has been lowered again for Fall 2025.

Senators raised concerns about service departments not serving faculty needs, particularly the new IT policy that only allows one device.

Dr. Hargrave shared that the call for internal grants is active. Eureka money is now embedded into all internal grants with an undergraduate supplement. Last year we won 32 million in grant awards. Look for an announcement in a couple of weeks about Bridge: Provost Innovation Fund, Centers of Excellence: Interdisciplinary Collaborative Proposals to build a center.

Policy Review Status Updates: Implementing new component to policy review lifecycle, which will feature status updates to Faculty Senate as senate-reviewed policies move through Academic Affairs Council processes. Senators were provided documentation on the new initiative for a Polytechnic College. Dr. White to visit with Faculty Senate on October 10th. Requesting volunteer to assist with taking minutes at September 19th meeting.
