### Called to Order.

3:31 PM, Loman Student Center room 304 by outgoing Chair Jonathan Breazeale. Chair's gavel was handed over to incoming senate Chair Anthony Watkins.

**Special Guests.** Dr. Dana Hoyt – University President, Dr. Richard Eglsaer – Provost and Vice President of Academic Affairs

President Hoyt recognized outgoing chair and senators for their service.

President Hoyt and Provost Eglsaer spoke about:

The vote by the Texas Higher Education Coordination Board on the School of Osteopathic Medicine which passed 5/4. She described the political fight with the commissioner of the board over the plan.

They addressed senator's concerns including:

 The broken elevators in the Lee Drain building and the instance of a wheelchair bound student being stuck on an upper floor due to the broken elevators. President Hoyt said she would bring it up with the appropriate groups on campus. She mentioned there are funds set aside to overhaul the Lee Drain building.

- Accessibility for disabled students across campus. Mention of a University of Houston study mapping accessibility of Texas universities and SHSU scored poorly. The Student government's autumn safety walk and the Faculty Senate's participation in the exercise was highlighted as a means to identify problems. Provost said that we work hard to correct inaccessibility when they become aware of it. Topography of campus is an inherent problem.
- The cost of parking. President Hoyt said that the costs are not going to get cheaper.
- The status of adjuncts, the number of classes they're asked to teach, and their pay. The President and Provost discussed some of the complexities of the issue. The Cabinet of Deans is discussing measures to improve things. The President would welcome Senate input on this topic. Mention was made of the problem with the current analytic tools incorrectly interpreting the data. The work being done by Stephanie Fors to better the use data and metrics to apportion classes.
- The number of grad students who are using the student foodbank is concerning. President Hoyt acknowledged the issue and added that the problem is a concern for undergraduates. She pointed to Dean Hendrickson's work on the grad student stipend, but we are still working to get to where we want to be on this issue.
