- Your children if you will provide more than 50% of their support from July 1, 2023 through June 30, 2024.
  - Children that are listed as "in college" must be: enrolled at least half time and have a birthdate **after** January 1, 2000.
  - Children that are dual enrolled while in high school can be included in the household but **not** as "in college."
